

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION # 10-69

**AWARDING BID TO SOUTH STATE, INC. FOR
THE RESURFACING OF GRIERS LANE**

WHEREAS, the Township of Upper Deerfield authorized bids with respect to the resurfacing of Griers Lane, a Township Road within the Township of Upper Deerfield; and

WHEREAS, bids were received on February 25, 2010; and

WHEREAS, South State, Inc. of Bridgeton, New Jersey, submitted the lowest bid in the amount of \$208,755.45 and a low bid for alternate number 1 in the amount of \$28,593.50 for additional services as set forth in the bid specifications; and

WHEREAS, the Engineer has recommended that the bid be awarded to South State, Inc. for both the base bid and the alternate number 1 bid for a total bid of \$237,348.95 as the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding a bid to South State, Inc. as aforesaid; and

WHEREAS, the award of the aforesaid bid to South State, Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of South State, Inc. be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the resurfacing of Griers Lane including alternate number 1 for a total amount of \$237,348.95 pursuant to a contract in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that the contractor shall be required to comply with the filing of CR 271 at least ten days prior to the execution of a contract; and

BE IT FURTHER RESOLVED that bid bonds may be returned to unsuccessful bidders;

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
