

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 11-135**

**APPROVAL OF CHANGE ORDER #9 -  
CONSTRUCTION OF NEW SEABROOK WATER TREATMENT FACILITY**

**WHEREAS**, a contract was awarded in the amount of \$2,544,000.00 to by Clyde Lattimer & Son Construction Company, Inc, for the construction of a new well #17 for the Seabrook Water System, together with radium removal and treatment plant for existing well #15 as well as well #17, as well as bids for the removal and disposal of spent media and furnishing and installing new media, provision of treatment for up to 1.5 billion gallons of water; and

**WHEREAS**, the contract amount was adjusted by change orders authorized by Resolutions 10-152, 10-176, 10-189, 10-211, 10-226, 11-83, 11-109, 11-110 with the final contract amount adjusted to \$2,714,985.00; and

**WHEREAS**, there is a need to remove one well pump in either in Well #15 or Well #17, replace it with a temporary, uncoated vertical turbine pump and column piping, temporarily wire the electric motor, pump the well at its full rate of 800 gpm and discharge the water through temporary a discharge hose, for a minimum of 24 hours. The water will then be sampled for the presence of aluminum at the end of the pumping procedure. If the test results show an aluminum sampling less than .2 mg/l there will be no cost associated with the change order if the test results show an aluminum sampling greater than .2 mg/l there will be a change order in the amount of \$10,499.00 in change orders; and

**WHEREAS**, the Township Engineer has recommended such work for this project; and

**WHEREAS**, funds are available and have been certified by the local finance officer; and

**NOW, THEREFORE, BE IT RESOLVED** that a change order in the amount of an increase of \$10,499.00 may be needed to the contract between by Clyde Lattimer & Son Construction Company, Inc, and the Township of Upper Deerfield to provide for the additional work is hereby approved; and

**BE IT FURTHER RESOLVED** that the final adjusted contract amount is hereby approved as \$2,725,484.00 if the change order amount is needed.
