**RESOLUTION # 11-155**

**AUTHORIZING AWARDING CONTRACT FOR PROVIDING REPAIRS OF CONTROL AND ALARM SYSTEMS AT THE TOWNSHIP’S LIFT STATIONS**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing repair of control and alarm system at the lift stations for a term of one year beginning July 1, 2011 to June 30, 2012 from Able Septic Services, Complete Control Services, Deltronics Corp, English Sewerage, Level – 1, M & S Services, Municipal Maintenance; and

**WHEREAS**, proposals were received from Complete Control Services, Inc., English Sewage Disposal and Municipal maintenance Co. as follows:

**WHEREAS**, the Treasurer has reviewed the proposals and determined that the lowest responsible proposal for repair of control and alarm system at the lift stations was submitted by English Sewage Disposal, and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for repair of control and alarm system at the lift stations to English Sewage Disposal as aforesaid.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposal for repair of control and alarm system at the lift stations by English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2011 to June 30, 2012 as noted above for the Township of Upper Deerfield; and
