

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 11-201**

**AMENDING PROFESSIONAL SERVICE CONTRACT TO  
BLAUER ASSOCIATES**

**WHEREAS**, there existed a need for professional services to administer the 2010 Small Cities Program for a Public Facilities Grant and a Housing Rehabilitation Grant governed by the New Jersey Department of Community Affairs on behalf of the Township of Upper Deerfield; and

**WHEREAS**, Resolution 09-132 authorized approval of a contract between Upper Deerfield Township and Blauer Associates to provide post approval administrative services if the applications were approved by the New Jersey Department of Community Affairs for an amount not to exceed \$16,000 per project

**WHEREAS**, the maximum funding level for the 2010 Small Cities Facilities application was increased from \$400,000 to \$500,000 which allowed the administrative service fee of 4% to be increased from \$16,000 to \$20,000 for the grant; and

**WHEREAS**, the fee charged to administer the Small Cities Home Rehabilitation Grant can be decreased from \$16,000 to \$12,000 because it was a continuation of a previous rehabilitation grant allowing for a reduction.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield as follows:

1. That Resolution 09-132 be amended for the 2010 Small Cities Facilities contract authorizing administrative services between Upper Deerfield Township and Blauer Associates be increased from an amount not to exceed \$16,000 to an amount not to exceed \$20,000.
2. That Resolution 09-132 be amended for the 2010 Small Cities Home Rehabilitation contract authorizing administrative services between Upper Deerfield Township and Blauer Associates be decreased from an amount not to exceed \$16,000 to an amount not to exceed \$12,000.
3. That the CFO and Treasurer receive a copy of this resolution

**BE IT FURTHER RESOLVED** that the award of this agreement for professional services is consistent with and in accordance with the provisions of N.J.S.A. 40A:11-1 et seq and N.J.S.A. 19:44-20.5.
