**RESOLUTION AWARDING BIDS FOR HOME REHABILITATION
CONTRACT 2011-01**

WHEREAS, the Township of Upper Deerfield authorized the receipt of bids for emergency repair rehabilitation portion of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Grant Funding; and

WHEREAS, bids were sought from Bob Watson, H.J. Graber Contractors Inc. and Pantarelli Construction.

WHEREAS, bids were received from Bob Watson for \$5,880.00, and Vince Pantarelli for \$4,280.00 with regard to the proposed project at 197 Landis Avenue; and

WHEREAS, Pantarelli Construction was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the aforesaid bid is in compliance with N.J.S.A. 19:44A-20.4, ET seq in that said bids were received as a result of competitive bidding;

WHEREAS, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the emergency repair rehabilitation portion bid for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Pantarelli Construction in the amount of \$4,280.00 for Contract 2011-01: Wayne Post, 197 Landis Avenue, Bridgeton NJ, 08302 to be funded by Small Cities Grant Funding; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Pantarelli Construction for the emergency repair rehabilitation portion of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
