**RESOLUTION AWARDING BID FOR HOME REHABILITATION
CONTRACT 2011-02**

WHEREAS, the Township of Upper Deerfield authorized the receipt of quotes for home rehabilitation of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Grant Funding; and

WHEREAS, quotes were sought from A.J. Petrunis, Dragon Heat, Modern Heating and Woodruff Energy; and

WHEREAS, quotes were received from A.J. Petrunis for \$6,995.00, Dragon Heat for \$4,800.00 (Lacked Proper Insurance), Modern Heating for \$4,795.00 and Woodruff Energy for \$6300.00 with regard to the proposed project at 33 Park Drive; and

WHEREAS, Modern Heating Service was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the aforesaid bid is in compliance with N.J.S.A. 19:44A-20.4, ET seq in that said bids were received as a result of competitive bidding;

WHEREAS, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the rehabilitation portion bid for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Modern Heating Service in the amount of \$4,795.00 for Contract 2011-02: Bridgett Cirri, 33 Park Drive, Bridgeton NJ, 08302 to be funded by Small Cities Grant Funding; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Modern Heating Service for the installation of a Burnham Boiler for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
