**AUTHORIZING AWARDING CONTRACT WITH A-CHECK AMERICA, INC.
FOR SUPPLYING BACKGROUND CHECKS FOR EMERGENCY SERVICE MEMBERS
IN UPPER DEERFIELD TOWNSHIP**

WHEREAS, the Township of Upper Deerfield requested proposals to provide background checks and/or drug screening reports for members of all emergency services associated with Upper Deerfield Township; and

WHEREAS, proposals were received from A-Check America, Inc., Detailed Investigations, and Check to Hire:

WHEREAS, the Treasurer has reviewed the proposals and determined that the lowest responsible proposal for performing background checks for all emergency service members associated with Upper Deerfield Township was submitted by A-Check America, Inc. in Glendale, California, and

WHEREAS, A-Check America, Inc. in Glendale, California will perform the background checks for all emergency service members associated with Upper Deerfield Township for a fee of \$20.00 per person and the State will receive a fee of \$12.00 fee for each drivers license check for a total cost of \$32.00 per member; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract performing background checks for all emergency service members associated with Upper Deerfield Township to A-Check America, Inc. as aforesaid.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal to provide background checks and/or drug screening reports for members of all emergency services associated with Upper Deerfield Township by A-Check America, Inc. is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award routine and emergency service for a term beginning November 1, 2011 to December 31, 2012 as noted above for the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection.
