**RESOLUTION AWARDING BID FOR HOME REHABILITATION
CONTRACT 2011-03**

WHEREAS, the Township of Upper Deerfield authorized the receipt of quotes for home rehabilitation of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Grant Funding and through Recaptured Funds; and

WHEREAS, bids were received on November 1, 2011, from HJ Graber Contractors, LLC for \$23,811.00, Robert H. Watson for \$24,930.00 and Start to Finish Contractors LLC for \$23,546.00 with regard to the home rehabilitation in compliance with specifications; and

WHEREAS, Start to Finish LLC was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the aforesaid bid is in compliance with N.J.S.A. 19:44A-20.4, ET seq in that said bids were received as a result of competitive bidding;

WHEREAS, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

WHEREAS, funds are available and have been certified by the local finance officer; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the rehabilitation portion bid for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Start to Finish LLC in the amount of \$23,546.00 for Contract 2011-03: Hugo and Ida Hintz, 165 Big Oak Road, Bridgeton NJ, 08302 to be funded by Small Cities Grant Funding of \$21,590.58 and Recaptured Funding of \$1,955.42; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Start to Finish LLC for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
