RESOLUTION 11-61

AMENDING THE 2011 TEMPORARY BUDGET - TOWNSHIP

WHEREAS, pursuant to the provisions of N.J.S.A. 40:4-19, it is necessary to make appropriations for the period between the beginning of the budget year and the adoption of the budget, if any contracts, commitments or payments are to be made prior to the adoption of the budget for the new fiscal year; and

WHEREAS, a resolution making such temporary appropriations was adopted on January 6, 2011; and

WHEREAS, the total of the appropriations so made, exclusive of the amount so appropriated for interest and debt redemption charges, and for relief of the poor, shall not exceed 26.25% of the total of the appropriations made for all purposes other than interest and debt redemption charges and for relief of the poor in the budget for the proceeding fiscal year; and

WHEREAS, a surplus balance of unused temporary budget allocation in the amount of \$85,697.02 remained after the adoption of the 2011 temporary budget.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield, in the County of Cumberland, that the following additional statement of appropriations will be added to current line items within the 2011 temporary budget and shall amend the temporary budget of the Township of Upper Deerfield, effective to the date of the fiscal adoption of the local budget for the fiscal year 2011.
