**AUTHORIZING PROFESSIONAL SERVICE AGREEMENT  
FOR ENVIRONMENTAL CONSULTING SERVICES**

**WHEREAS**, there exists a need for environmental consulting services for the 2012 Small Cities Housing Rehabilitation Grant; and

**WHEREAS**, Joseph T. Kenney t/a Services Building and Environmental Consultant is certified and licensed as an environmental consultant and inspector in the area of lead evaluation; and

**WHEREAS**, the Township of Upper Deerfield is in need of such services; and

**WHEREAS**, this contract is awarded without competitive bidding as a professional service contract in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law, because said services are exempt pursuant to the provisions of the law.

**WHEREAS**, the contract is below the bid threshold with respect to Pay to Play requirements pursuant to N.J.S.A. 19:44A-20.4, et seq.; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of contracting for such services;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield as follows:

1. That the allegations of the preamble hereto are incorporated herein as if fully set forth
2. The Mayor and the Township Clerk are hereby authorized and directed to execute an agreement with Joseph T. Kenney t/a Services Building and Environmental Consultant., 140 Persimmon Street, Glassboro, NJ 08028 as an environmental consultant and inspector in the area of lead evaluation for the 2012 New Jersey Small Cities Housing Rehabilitation Program as set forth in the proposed agreement, Joseph T. Kenney t/a Services Building and Environmental Consultant will charge in accordance with the schedule of fees attached hereto and made a part hereof for lead inspection services.
3. This contract is awarded without competitive bidding as a professional service in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law, because said services are exempt pursuant to the provisions of the law.
4. A copy of the agreement has been filed with the Township Clerk and is available for public inspection in the office of the Township Clerk during normal business hours.
5. The Business Entity Disclosure Certification is not required as the contract is below the bid threshold with respect to Pay to Play requirements.

6. That a copy of the specific items pertaining to the award of this contract shall be published in a Notice of Award in the News of Cumberland County
