

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION # 12-148**

**AUTHORIZING AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS  
WITHIN THE TOWNSHIP**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing the pumping out of lift stations within the Township for a term of one year beginning July 1, 2012 to June 30, 2013 from Able, C & H Disposal Service, English Sewage Disposal and Pierce Septic Services ; and

**WHEREAS**, proposals were received from English Sewage Disposal as follows:

**WHEREAS**, the Treasurer has reviewed the proposals and determined that the lowest responsible proposals were submitted by C & H Disposal for daytime hours and English Sewage Disposal for evening, weekend & emergency hours, and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for providing lift stations pump out services to C & H Disposal and English Sewage Disposal as aforesaid.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposal for providing lift stations pump out services by English Sewage Disposal & C & H Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2012 to June 30, 2013 as noted above for the Township of Upper Deerfield; and

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposals for providing lift stations pump outs by C & H Disposal for daytime hours and English Sewage Disposal for evening, weekend & emergency hours are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award C & H Disposal and English Sewage Disposal for a term of one year beginning July 1, 2012 to June 30, 2013 as noted above for the Township of Upper Deerfield; and
