RESOLUTION # 12-151

AUTHORIZING AWARDING CONTRACT FOR PROVIDING REPAIRS OR REPLACEMENT OF LIFT STATION PUMPS IN THE TOWNSHIP

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing repairs or replacement of lift station pumps within the Township for a term of one year beginning July 1, 2012 to June 30, 2013 from Complete Control Services, Deltronics Corp., English Sewage Disposal, Level-1, Municipal Maintenance; and

WHEREAS, proposals were received from Deltronics Corp., English Sewage Disposal and Municipal Maintenance Co. as follows:
