**RESOLUTION AWARDING BID FOR HOME REHABILITATION
CONTRACT 2012-14**

WHEREAS, the Township of Upper Deerfield authorized the receipt of quotes for home rehabilitation of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Revolving Loan Account; and

WHEREAS, the Township of Upper Deerfield requested proposals with respect to Home Rehabilitation for Christina & Danny Godfrey, 1494 Highway 77 from All and All Construction, Gemini Building Co, H.J. Graber Contractors, Inc., Pantarelli Homes and Robert H. Watson; and

WHEREAS, only one proposal was received on September 19, 2012, from Robert H. Watson for \$5,560 with regard to the home rehabilitation in compliance with specifications; and

WHEREAS, Robert H. Watson was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

WHEREAS, funds are available and have been certified by the local finance officer; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the rehabilitation portion proposal for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Robert H. Watson in the amount of \$5,560.00 for Contract 2012-14: Christina & Danny Godfrey, 1494 Highway 77, Bridgeton NJ, 08302 to be funded by Small Cities Revolving Loan Account; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Robert H. Watson for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
