RESOLUTION 12-262

**RESOLUTION AUTHORIZING AWARD OF CONTRACT
FOR EAST LOOP WATER MAIN EXTENSION TO
T & W CONSTRUCTION CO., LLC**

WHEREAS, the Township of Upper Deerfield has advertised for bids for the construction of a water system loop to the existing Township water system on the eastern side of the Township known as the East Loop Water Main Extension Project; and

WHEREAS, bids were received by the Township of Upper Deerfield on October 25, 2012; and

WHEREAS, the low bid was received from T&W Construction Co., LLC in the amount of \$567,884.95; and

WHEREAS, there was a mathematical error with respect to the calculation of the total bid in the amount of \$200; and

WHEREAS, the correct bid number is \$567,684.95, not \$567,884.95; and

WHEREAS, the bids have been reviewed by the Township Engineer of the Township of Upper Deerfield and a recommendation received that the bid in the amount of \$567,684.95 is the lowest responsible bid and T & W Construction Co., LLC is the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to T & W Construction Co., LLC in the amount of \$567,684.95 to complete the Township of Upper Deerfield East Loop Water Main Extension Project in accordance with plans and specifications subject to approval by the United States Department of Agriculture;

NOW THEREFORE, be it resolved by the Township Committee of the Township of Upper Deerfield that the bid of T & W Construction Co., LLC in the amount of \$567,684.95 to construct the east loop water main extension to the Township water system in accordance with plans and specifications is hereby awarded; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield and is further conditioned upon approval by the United States Department of Agriculture; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with T & W Construction Co., LLC for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
