

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION # 13-153

AUTHORIZING AWARDING CONTRACT FOR PROVIDING REPAIRS OF CONTROL AND ALARM SYSTEMS AT THE TOWNSHIP’S LIFT STATIONS

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing repair of control and alarm system at the lift stations for a term of one year beginning July 1, 2013 to June 30, 2014 from Able Septic Services, Complete Control Services, Deltronics Corp, English Sewerage, Level – 1, M & S Services, Municipal Maintenance; and

WHEREAS, proposals were received from Complete Control System, Deltronics Corp., English Sewage Disposal and Municipal Maintenance Co. as follows:

WHEREAS, the Treasurer has reviewed the proposals and determined that the lowest responsible proposal for repair of control and alarm system at the lift stations was submitted by Deltronics Corp, and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for repair of control and alarm system at the lift stations to Deltronics Corp as aforesaid.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for repair of control and alarm system at the lift stations by Deltronics Corp. is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2013 to June 30, 2014 as noted above for the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection.
