

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION # 13-211**

**IMPOSING LIEN ON BLOCK 2401, LOT 21 – 142 LANIDS AVENUE-REED**

**WHEREAS**, the property known as Block 2401, Lot 21 on the Tax Map of the Township of Upper Deerfield, 142 Landis Avenue, with current owner of record listed as Richard Reed, had become overgrown with brush, weeds, dead or dying trees, trash, and other debris; and

**WHEREAS**, the Township of Upper Deerfield notified the owner with respect to the conditions on the property pursuant to Section 57-3 of the Code of the Township of Upper Deerfield; and

**WHEREAS**, the owner of said property either refused or neglected to address and abate the conditions on the property; and

**WHEREAS**, the Township of Upper Deerfield, in accordance with Section 57-5 and 57-6 of the Code of the Township of Upper Deerfield, undertook to abate the conditions on the property and to clean up the property; and

**WHEREAS**, the Township of Upper Deerfield has incurred costs to clean-up the grounds of Block 2401, Lot 21, 142 Landis Avenue in the amount of \$50.00 on July 29, 2013; and

**WHEREAS**, the cost of such services has been certified to the Township Committee of the Township of Upper Deerfield;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the amount of \$50.00 be and the same is hereby certified as a lien against Block 2401, Lot 21; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that a certified copy of this resolution shall be filed with the collector of taxes and the amount charged hereunder, \$50.00 shall become a lien and shall added to and become part of the taxes next to be assessed and levied upon Block 2401, Lot 21 and shall bear interest at the same rate as taxes and may be enforced and collected to the same extent and in the same manner as unpaid taxes.
