

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION # 13-220**

**AUTHORIZING AWARDING CONTRACT FOR SERVICE ON EMERGENCY VEHICLES**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing service work on emergency vehicles within the Township for a term of one year beginning August 15, 2013 to August 14, 2014 from Cruzan’s Freightliner, First Priority,, N.J.O.V.E., and E.V.S.; and

**WHEREAS**, proposals were received from Cruzan’s Freightliner, First Priority and E.V.S. as follows:

**WHEREAS**, the Treasurer has reviewed the proposals and determined that Cruzan’s Freightliner submitted the lowest responsible proposal for annual chassis and lube service and that E.V.S. submitted the lowest proposal for pump, generator and aerial service and miscellaneous hourly repairs; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the services for Emergency Vehicles to Cruzan’s Freightliner and E.V.S., as aforesaid.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposal to provide annual chassis and lube service by Cruzan’s Freightliner and the proposal by E.V.S. to provide pump, generator and aerial service and miscellaneous hourly repairs are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award routine and emergency service for a term of one year beginning August 15, 2013 to August 14, 2014 as noted above for the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** that the proper account numbers will be charged and funds encumbered prior to services being provided and said contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2013 and 2014 budgets; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection.
