**RESOLUTION AWARDING BID FOR HOME REHABILITATION  
CONTRACT 2013-10**

**WHEREAS**, the Township of Upper Deerfield authorized the receipt of quotes for a water well replacement for a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Revolving Loan Account; and

**WHEREAS**, the Township of Upper Deerfield received proposals replace the water well for Vedora Federico at 5 Pleasant Drive in the amount of from Calabrese Well Drilling - \$4,350, D'Agostino's Water Solutions, LLC - \$4,200 and Roesly Well Drilling - \$4,850; and

**WHEREAS**, D'Agostino's Water Solutions, LLC was deemed to be the lowest responsible bidder for the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

**WHEREAS**, funds are available and have been certified by the local finance officer; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the water well replacement proposal for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to D'Agostino's Water Solutions, LLC in the amount of \$4,200.00 for Contract 2013-10: Vedora Federico, 5 Pleasant Drive, Bridgeton NJ, 08302 to be funded by Small Cities Revolving Loan Account; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with D'Agostino's Water Solutions, LLC for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
