**AUTHORIZING AWARD OF CONTRACT FOR COLONIAL TERRACE DRAINAGE
SWALE TO PERNA CONSTRUCTION, LLC**

WHEREAS, the Township of Upper Deerfield has advertised for bids for the construction of a drainage system for Colonial Terrace; and

WHEREAS, bids were received by the Township of Upper Deerfield on March 5, 2013; and

WHEREAS, bids were received from Perna Construction LLC - \$100,500.00, Ricky Slade Construction - \$114,377.00, Jerry & Son Excavation, Inc. - \$123,450.00, Don Rogers, Inc. - \$125,820.00, Spencer Maussner - \$151,450.00, Neri's Construction - \$155,715.00, T&W Construction Co., LLC - \$178,047.75 and GWP Enterprises - \$179,513.75; and

WHEREAS, the bids have been reviewed by the Township Engineer of the Township of Upper Deerfield and a recommendation received that the bid in the amount of \$567,684.95 is the lowest responsible bid and Perna Construction LLC is the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to Perna Construction LLC in the amount of \$100,500.00 to construct a drainage system for Colonial Terrace in accordance with plans and specifications;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of Perna Construction LLC in the amount of \$100,500.00 to construct a drainage system for Colonial Terrace in accordance with plans and specifications is hereby awarded; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with Perna Construction LLC for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
