AUTHORIZING AWARDING OF CONTRACT FOR SPRING ACTIVATION AND FALL WINTERIZATION TO CERTAIN UNDERGROUND IRRIGATION SYSTEMS WITHIN THE TOWNSHIP OF UPPER DEERFIELD

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing spring activation and fall winterization to irrigation systems within the Township beginning April 5, 2013 to December 31, 2013 from Dutch Neck Landscaping, Rainbow Sprinklers, TBI Unlimited, and Wetlawn Automatic Sprinkler Systems; and
