ORDINANCE # 720

AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS OF THE TOWNSHIP OF UPPER DEERFIELD IN THE COUNTY OF CUMBERLAND, PROVIDING THE TERMS OF PAYMENT THEREOF AND REPEALING ORDINANCES INCONSISTENT THEREWITH,

BE IT ORDAINED by the Township Committee of the Township of Upper Deerfield, in the County of Cumberland; that:

Section 1. The following job titles shall have an annual salary with the following salary ranges:

Section 4. The aforesaid annual salaries shall be payable at such time as may be approved by the Township Committee as set forth herein and shall be in lieu of all fees which may be otherwise due, which fees shall upon collection be forewith paid over to the Township Treasurer.

Section 5. Ordinances No. 685, 702, and 717 and all other ordinances and parts of ordinances inconsistent herewith are hereby repealed.

Section 6. This ordinance shall take effect for all persons employed by the township as of January 1, 2015, and be subject to publication as required by law, and shall be in effect until further action of the Township Committee.
