RESOLUTION 14-134

**AUTHORIZING AWARD OF CONTRACT FOR THE
MUNICIPAL PARKING LOT EXPANSION AND WALKPATHS**

WHEREAS, the Township of Upper Deerfield has advertised for bids for the construction of the municipal parking lot expansion and walkpaths; and

WHEREAS, bids were received by the Township of Upper Deerfield on June 3, 2014 from Asphalt Paving Corp. - \$212,231.35, GWP Paving - \$292,734.00, Krisanna Construction - \$301,752.50 and Ricky Slade Construction - \$231,855.50; and

WHEREAS, the low base bid was received from Asphalt Paving Corp. in the amount of \$212,231.35; and

WHEREAS, the bids have been reviewed by the Township Engineer, and a recommendation received that the base bid in the amount of \$212,231.35 is the lowest responsible bid and Asphalt Paving Corp. is the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to Asphalt Paving Corp. in the amount of \$212,231.35 for the construction of the municipal parking lot expansion and walkpaths pursuant to the bidding documents;

WHEREAS, the award of the aforesaid bid to Asphalt Paving Corp. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the base bid of Asphalt Paving Corp. in the amount of \$212,231.35 for the construction of the municipal parking lot expansion and walkpaths, in accordance with plans and specifications is hereby awarded; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with Asphalt Paving Corp. for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
