

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 14-209**

**IMPOSING LIEN ON BLOCK 705, LOT 2.08 - 340 WOODRUFF RD - PACE**

**WHEREAS**, the property known as Block 705, Lot 2.08 on the Tax Map of the Township of Upper Deerfield, 340 Woodruff Road, with current owner of record listed as Angelo Pace, Jr., had become overgrown with brush, weeds, dead or dying trees, trash, and other debris; and

**WHEREAS**, the Township of Upper Deerfield notified the owner with respect to the conditions on the property pursuant to Section 57-3 of the Code of the Township of Upper Deerfield; and

**WHEREAS**, the owner of said property either refused or neglected to address and abate the conditions on the property; and

**WHEREAS**, the Township of Upper Deerfield, in accordance with Section 57-5 and 57-6 of the Code of the Township of Upper Deerfield, undertook to abate the conditions on the property and to clean up the property; and

**WHEREAS**, the Township of Upper Deerfield has incurred costs to clean-up the grounds of Block 705, Lot 2.08, 340 Woodruff Road in the amount of \$65.00 on July 31, 2014; and

**WHEREAS**, the cost of such services has been certified to the Township Committee of the Township of Upper Deerfield;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the amount of \$65.00 be and the same is hereby certified as a lien against Block 705, Lot 2.08; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that a certified copy of this resolution shall be filed with the collector of taxes and the amount charged hereunder, \$65.00 shall become a lien and shall added to and become part of the taxes next to be assessed and levied upon Block 705, Lot 2.08 and shall bear interest at the same rate as taxes and may be enforced and collected to the same extent and in the same manner as unpaid taxes.
