AUTHORIZING AWARD OF CONTRACT FOR THE INSTALLATION OF REPLACEMENT WINDOWS AT THE MUNICIPAL BUILDING

WHEREAS, the Township of Upper Deerfield has requested proposals for the installation of replacement windows at the Municipal Building; and

WHEREAS, proposals were received by the Township of Upper Deerfield from Garozzo & Scimeca Construction - \$19,800.00 and Aries Window & Door - \$9,970.00. Alberta Windows & Doors and Steve Vodges did not submit a proposal; and

WHEREAS, the bids have been reviewed by the Township Engineer, and a recommendation received that the proposal from Aries Window & Door in the amount of \$9,970.00 is the lowest responsible proposal; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to Aries Window & Door in the amount of \$9,970.00 for the installation of replacement windows at the Municipal Building;

WHEREAS, the award of the aforesaid bid to Aries Window & Door is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal of Aries Window & Door in the amount of \$9,970.00 for the installation of replacement windows at the Municipal Building is hereby awarded; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the award of this proposal is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with Aries Window & Door for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield.
