RESOLUTION 15-55

**AUTHORIZING INSTALLMENT TAX PAYMENTS REGARDING
BLOCK 102, LOT 2.01 ON THE TAX MAP OF THE TOWNSHIP OF UPPER DEERFIELD**

WHEREAS, there are arrearages with respect to property taxes due and owing with respect to Block 102, Lot 2.01 on the Tax Map of the Township of Upper Deerfield which property is owned by Christina Verna and commonly known as 1748 Highway 77 within the Township of Upper Deerfield; and

WHEREAS, the owner has requested that they be allowed to enter into an installment payment plan with respect to the payment of such tax arrearages; and

WHEREAS, redemption of arrearages is permissible pursuant to N.J.S.A. 54:5-65, et seq.; and

WHEREAS, as of February 5, 2015, the tax collector of the Township of Upper Deerfield has calculated arrearages together with interest through December 31, 2015, in the amount of \$3,377.17 and has recommended the allowance of the tax installment plan on behalf of the tax payer;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that Christina Verna of 1748 Highway 77, owner of property known as Block 102, Lot 2.01 on the Tax Map of the Township of Upper Deerfield be and is hereby permitted to pay property tax arrearages which have accumulated in the amount of \$2,922.69 together with interest to December 31, 2015, of \$454.48; and

BE IT FURTHER RESOLVED that the payment plan to liquidate the foregoing arrearages shall be made over a period of 10 months in the amount of \$337.72 per month commencing on March 1, 2015, and ending December 1, 2015; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the payment of tax arrearages pursuant to the foregoing installment payment plan shall be conditioned upon current taxes together with any additional accumulated interest being paid in a timely fashion.
