

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 16-99

APPOINTING TOWNSHIP PLUMBING SUBCODE OFFICIAL FOR SHARED SERVICE AGREEMENT AND CERTIFYING SALARY

WHEREAS, the Township of Upper Deerfield and the City of Millville are entering into a shared service agreement whereby the Township of Upper Deerfield will be providing construction office services to the City of Millville; and

WHEREAS, the Township of Upper Deerfield will need to hire additional construction office officials to carry out the shared service agreement; and

WHEREAS, in the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the officials hired under this resolution will be terminated from the designated position and the salary associated with the positions listed will be pro-rated to the last day the shared service agreement is in effect.

NOW THEREFORE BE IT RESOLVED, that the following officials and employees are hereby appointed to serve the Township during 2016 for the sole purpose of filling the positions required to carry out the shared service agreement for construction office code review and inspections services with the City of Millville; and

BE IT FURTHER RESOLVED, that in the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the officials hired under this resolution will be terminated from the designated position and the salary associated with the positions listed will be pro-rated to the last day the shared service agreement is in effect; and

BE IT FURTHER RESOLVED that John Lamanteer is hereby appointed as Plumbing Sub Code Official for the Millville Shared Service at a pro-rata annual salary of \$20,000 per year, authorized by the ranges specified in Ordinance No. 732, for a term not to exceed December 31, 2016 or the last day the shared service agreement with Millville is in effect, whichever shall come first. In the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the Plumbing Sub Code Official for the Millville Shared Service hired under this resolution will be terminated on the last day the shared service agreement is in effect and the salary associated with that position listed will be pro-rated to the last day the shared service agreement is in effect.
