

DRINKING WATER WARNING

Upper Deerfield Township's water has high levels of nitrate

Nitrate contaminated water affects customers south of Big Oak Road and South of Finley Road

**DO NOT GIVE THE WATER TO INFANTS UNDER 6 MONTHS OLD
OR USE IT TO MAKE INFANT FORMULA**

Bottled water will be provided to families with infants less than six months old at 1325 Highway 77, Upper Deerfield Township NJ.

On 10/2/2018, we received notice that a sample collected on 10/2/2018 showed a nitrate concentration in the drinking water of 11.9 milligrams per liter (mg/L). On 10/3/2018 we received notice that a confirmation sample collected on 10/3/2018 showed a nitrate concentration in the drinking water of 10 mg/L. The 10.95 mg/L average of these two samples is above the nitrate standard, or maximum contaminant level of 10 mg/L. Nitrate in drinking water is a serious health concern for infants less than six months old. Nitrate in drinking water can come from natural, industrial, or agricultural sources (including septic systems and run-off). Levels of nitrate in drinking water can vary throughout the year.

What should I do? What does this mean?

- **DO NOT GIVE THE WATER TO INFANTS.** **Infants below the age of six months who drink water containing nitrate in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome.** Blue baby syndrome is indicated by blueness of the skin. Symptoms in infants can develop rapidly, with health deteriorating over a period of days. If symptoms occur, seek medical attention immediately.
- Water, juice, and formula for children under six months of age should not be prepared with tap water. Bottled water or other water low in nitrates should be used for infants until further notice.
- **DO NOT BOIL THE WATER.** Boiling, freezing, filtering, or letting water stand does not reduce the nitrate level. Excessive boiling can make the nitrates more concentrated, because nitrates remain behind when the water evaporates.
- Adults and children older than six months can drink the tap water (nitrate is a concern for infants because they can't process nitrates in the same way adults can). However, if you are pregnant or have specific health concerns, you may wish to consult your doctor.

What is being done?

We are assessing the source water and treatment options to provide water compliant with the nitrate standard again. We will inform you when this problem has been corrected. For more information, please contact John Hoogendorn at the Upper Deerfield Township Water Department at 856-451-3811.
