RESOLUTION # 10-172

**AUTHORIZING AWARDING BID TO C. B. STRUCTURES, INC.
REGARDING THE CONSTRUCTION OF A SALT SHED ON OLD BURLINGTON ROAD**

WHEREAS, the Township of Upper Deerfield advertised bids to construct a salt shed on Old Burlington Road; and

WHEREAS, bids were received on August 3, 2010, which were duly advertised and publicly opened; and

WHEREAS, C.B. Structures, Inc. of New Holland, Pennsylvania, submitted the lowest bid in the amount of \$84,885.00, bids were also received from TNT Construction - \$133,838.00, Art Anderson, Inc. - \$129,000.00, Parrish Construction - \$99,850.00 and WJ Gross - \$140,000.00; and

WHEREAS, the Engineer has reviewed the bids and determined that the lowest responsible bid was submitted by C.B. Structures, Inc. of New Holland, Pennsylvania, in the amount of \$84,885.00; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding a bid to C.B. Structures, Inc., as aforesaid; and

WHEREAS, the award of the aforesaid bid to C.B. Structures, Inc., is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of C.B. Structures, Inc., be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the construction of a salt shed on Old Burlington Road for a total amount of \$84,885.00 pursuant to a contract in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that the contractor shall be required to comply with the filing of CR 271 at least ten days prior to the execution of a contract; and

BE IT FURTHER RESOLVED that bid bonds may be returned to unsuccessful bidders;

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
