RESOLUTION 10-44

APPOINTING PLANNING BOARD ENGINEER – ROBERT DUBOIS

WHEREAS, there exists the need for the “Professional Services” of a TOWNSHIP PLANNING BOARD ENGINEER, to be retained by the Township for the performance of planning services and related duties associated therewith as directed by the authorized representatives of the Township of Upper Deerfield, as more specifically set forth in the Professional Services Agreement; and

WHEREAS, the Township of Upper Deerfield has advertised Requests for Proposals for the position of Township Planning Board Engineer of the Township of Upper Deerfield; and

WHEREAS, Robert DuBois, PE, has submitted a response to the Request for Proposal; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the Request for Proposal to Robert DuBois, PE and appointing him as Township Planning Board Engineer of the Township of Upper Deerfield pursuant to a Professional Service Contract for the year 2010.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Upper Deerfield, County of Cumberland and State of New Jersey, as follows:

1. That the allegations of the preamble hereto are incorporated herein as if fully set forth.
2. That Robert DuBois of Mullica Hill, New Jersey, a Professional Engineer in the State of New Jersey, be appointed Township Planning Board Engineer for Upper Deerfield Township for the year 2010 to perform professional services ordinarily provided by a planner, and shall receive compensation in accordance with terms of the contract on file in the clerk’s office.
3. That the aforesaid contract is awarded pursuant to competitive bidding as a “Professional Service” under the provisions of the Local Public Contracts Law because N.J.S.A.40A:11-5 states that no local unit shall be required to advertise for bids for services rendered or performed by a person authorized by law to practice a recognized profession and whose practice is regulated by law, or to advertise for bids for services which are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids, all of which classification the aforesaid contract falls within.
4. That a copy of the specific items pertaining to the award of this contract shall be published in a Notice of Award in the News of Cumberland County as required by law within ten (10) days of the Resolution authorizing same; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that this professional service agreement is awarded pursuant to and subject to the provisions of Pay to Play legislation, N.J.S.A. 19:44A-20.4, et seq.
