RESOLUTION # 10-52

AUTHORIZING PROFESSIONAL SERVICE AGREEMENT LOU JOYCE

WHEREAS, there exists a need for professional planning services in the Township of Upper Deerfield; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for professional services without competitive bids, and the contract itself, must be available for public inspection; and

WHEREAS, the Township Committee deems it to be in the best interests of the residents of the Township of Upper Deerfield to award a contract for planning services to Louis C. Joyce, IV, PP, AICP for the provision of planning services in connection with the following projects:

1. Services in connection with the preparation of the Redevelopment Plan for Redevelopment Area South in the Township of Upper Deerfield as may be requested;
2. Completion and preparation of Housing Element and Fair Share Housing Plan for approval by either the Council on Affordable Housing or the Court in the matter of Sunset Lake 100, LLC v. Township of Upper Deerfield, Docket No. L-178-03;
3. Such other special projects as the Township Committee may approve from time to time in connection with planning, zoning, and redevelopment.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield as follows:

1. The Mayor and the Township Clerk are hereby authorized and directed to execute an agreement with Louis C. Joyce, IV, for the provision of planning services at \$95 an hour for the projects outlined above.

2. This contract is awarded without competitive bidding as a professional service in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law, because said services are to be performed by a person authorized by law to practice a recognized profession.

3. A copy of the agreement has been filed with the Township Clerk and is available for public inspection in the office of the Township Clerk during normal business hours.

4. A notice of this action shall be printed once in the News of Cumberland County.

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that this professional service agreement is awarded pursuant to and subject to the provisions of Pay to Play legislation, N.J.S.A. 19:44A-20.4, et seq., in that the contractor has agreed to execute the Pay to Play exemption certification and has or will certify that the contractor has not during the last 12 months preceding the award of this contract nor during the succeeding 12 months contributed or will contribute campaign contributions in excess of reportable limits in accordance with the aforesaid legislation.
