RESOLUTION 10-64

RESOLUTION AUTHORIZING AN INSTALLMENT PLAN WITH RESPECT TO THE PAYMENT FOR RECONCILIATION OF THE CALCULATION OF HIGH STRENGTH SEWERAGE CHARGES ON BEHALF OF CLEMENT PAPPAS, BLOCK 905, LOT 1 ON THE TAX MAP OF THE TOWNSHIP OF UPPER DEERFIELD

WHEREAS, Clement Pappas, the owner of a parcel of property known as Block 905, Lot 1 on the Tax Map of the Township of Upper Deerfield, Parsonage Road, Seabrook, New Jersey, and the Township of Upper Deerfield have agreed upon the calculation for high strength commercial/industrial charges as determined by Chapter 82-27 of the Code of the Township of Upper Deerfield for the time period of 2004 through 2009; and

WHEREAS, Clement Pappas has requested that they be allowed to enter into a three year installment payment plan with respect to the payment of such sewerage charges; and

WHEREAS, as of February 4, 2010, the total arrearages due is \$306,725.28; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of allowing an installment plan to be entered into and such installment plan is authorized pursuant to N.J.S.A. 54:5-19.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the Tax Collector be and is hereby authorized to accept installment payments with respect to the sewer usage calculation for high strength commercial/industrial charges as determined by Chapter 82-27 of the Code of the Township of Upper Deerfield in the amount of \$306,725.28 as of February 4, 2010; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the payments will be made quarterly commencing on March 31, 2010, in the amount of \$25,560.44 per quarter for a period of 12 quarters ending on December 31, 2012 with payment dates of March 31, June 30, September 30, and December 31; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the aforesaid installment plan is conditioned and contingent upon all current taxes, water, and sewer payments being kept current by Clement Pappas with respect to the aforesaid property.
