

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION # 10-80

**AUTHORIZING CONTRACT FOR ANIMAL CONTROL SERVICES
WITH COUNTYWIDE ANIMAL CARE AND CONTROL, LLC**

WHEREAS, the Township of Upper Deerfield has need for animal controls services; and

WHEREAS, such services were previously provided pursuant to an interlocal agreement with the City of Bridgeton which has been rescinded; and

WHEREAS, the Township is in need of animal control services for the year 2010; and

WHEREAS, quotes have been obtained for such services and on an annualized basis in the amount of \$800 per month from Countywide Animal Care and Control, LLC; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding a contract to Countywide Animal Care and Control, LLC for \$800 monthly for the balance of 2010;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that an animal control contract is hereby awarded to Countywide Animal Care and Control, LLC in the amount of \$800 per month commencing April 1, 2010, through December 31, 2010; and

BE IT FURTHER RESOLVED that the Mayor and Clerk be and are hereby authorized to enter into a contract with Countywide Animal Care and Control, LLC in a form satisfactory to the Township Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that this agreement is exempt from the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq. and the Pay to Play legislation, N.J.S.A. 19:44A-20.4, et seq. in that quotes have been solicited and the contract amount is less than the bid threshold limits and Pay to Play threshold.

BE IT FURTHER RESOLVED that the execution of the contract is conditioned upon the contractor completing Form CR 271 at least ten days prior to the execution of the contract; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
