

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION # 11-144**

**AUTHORIZING AWARDING CONTRACT FOR SUPPLYING CHEMICALS TO THE WATER PLANTS IN UPPER DEERFIELD TOWNSHIP**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing chemicals to the water plants for a term of one year beginning July 1, 2011 to June 30, 2012; and

**WHEREAS**, proposals were received from Coyne Chemical, Del Vel Chem Company and Hibrett Puratex as follows:

**WHEREAS**, the Treasurer has reviewed the proposals and determined that the lowest responsible proposals for chemicals were submitted by Coyne Chemical for the 68% Calcium Hypochloride Tablets, Del Vel Chem Company for 5 gallon pails of 15% Sodium Hypochloride and orders of 9 fifty pound bags or less of Calcium Hydroxide and to Hibrett Puratex for Calcium Hydroxide of orders greater than 10 fifty pound bags; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for supplying chemicals to Coyne Chemical, Del Vel Chem Company and Hibrett Puratex as aforesaid.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposals for chemicals submitted by Coyne Chemical for the 68% Calcium Hypochloride Tablets, Del Vel Chem Company for 5 gallon pails of 15% Sodium Hypochloride and orders of 9 fifty pound bags or less of Calcium Hydroxide and to Hibrett Puratex for Calcium Hydroxide of orders of 10 or more fifty pound bags are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award chemical supply for a term of one year beginning July 1, 2011 to June 30, 2012 as noted above for the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection.
