

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION # 11-150**

**AUTHORIZING AWARDING CONTRACT FOR PROVIDING JETTING / VACCING PIPES  
WITHIN THE TOWNSHIP**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing jetting and or vaccing sewer pipes and or storm drainage pipes within the Township for a term of one year beginning July 1, 2011 to June 30, 2012 from Crown Pipeline, English Sewage Disposal, GE Mechanical Inc, M&S Service Co., Inc., Municipal Maintenance Co., Video Pipe Services; and

**WHEREAS**, proposals were received from English Sewage Disposal, GE Mechanical, Inc. and Video Pipe Services, Inc. as follows:

	English	GE Mechanical	Video Pipe
Daytime Hourly Rate	\$400 Trip Charge with \$100/hour. Min charge for first hour is \$500.00	228.80	165.00 Minimum of 4 hours = \$660.00
Evening, Weekend, Emergency Hourly Rate	\$400 Trip Charge with \$100/hour. Min charge for first hour is \$500.00	269.36	185.00 Minimum of 4 hours = \$740.00

**WHEREAS**, the Treasurer has reviewed the proposals and determined that the lowest responsible proposals were submitted by GE Mechanical, Inc. for projects requiring two hours or less of service and to Video Pipe Services for any project requiring more than two hours of service; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the services for providing jetting and or vaccing sewer pipes and or storm drainage pipes to GE Mechanical, Inc. and Video Pipe Services, as aforesaid.

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the proposal for jetting / vaccing sewer pipes and or storm drainage pipes by GE Mechanical Inc., for projects requiring two hours or less of service and the proposal by Video Pipe Services for any project requiring more than two hours of service are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award routine and emergency service for a term of one year beginning July 1, 2011 to June 30, 2012 as noted above for the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection.
