AUTHORIZING AWARDING CONTRACT FOR PROVIDING PREVENTATIVE MAINTENANCE TO BOILERS, HEATERS AND AIR CONDITIONERS WITHIN THE TOWNSHIP

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing preventative maintenance to boilers, heaters and air conditioners within the Township for a term of one year beginning July 1, 2011 to June 30, 2012 from A.J. Petrunis, Dorrington CJ Commercial, Laury Heating, Mathis and Tiny’s Plumbing Heating & AC; and
