**AWARDING SERVICES FOR PROVIDING SNOW REMOVAL FOR THE
UPCOMING SEASON TO VARIOUS ROADS WITHIN UPPER DEERFIELD
TOWNSHIP**

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing snow removal services within the Township for a term of one year beginning September 1, 2011 to August 31, 2012 from Angelo DiLeonardo, C & H Disposal Services Inc., English Sewage Disposal, H & S DuBois, Ricky Slade Construction, Spring Brook Farms, TBI Unlimited, Team Reed Landscaping Inc., S & R Contractors.; and

WHEREAS, proposals were received from C & H Disposal Service, Inc and TBI Unlimited as follows:
