

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 12-188**

**AWARDING BID FOR ONE (1) CLASS I, TYPE I  
MODULAR AMBULANCE**

**WHEREAS**, the Township of Upper Deerfield has advertised for and received bids on June 26, 2012, with respect one Type I, Class I Modular Ambulance; and

**WHEREAS**, PL Custom Body & Equipment Co., Inc. has submitted a bid in the amount of One Hundred Eighty Two Thousand One Hundred Seventy One Dollars (\$182,171.00), less credit for trade-in of one 1999 AEV Type II Ambulance in the amount of Ten Thousand Dollars (\$10,000); and

**WHEREAS**, a bid was received from First Priority Emergency Vehicles, Inc. in the amount of One Hundred Seventy Thousand Two Hundred Fifty Six Dollars (\$170,256.00) together with trade-in credit in the amount of \$6,000; and

**WHEREAS**, a review of the bids and compliance with specifications has been undertaken by the Township; and

**WHEREAS**, the bid of First Priority Emergency Vehicles, Inc. is deemed to be nonconforming and not in compliance with specifications; and

**WHEREAS**, a review of the bids by personnel of the Township Emergency Medical Services reveals numerous deviations from specifications as set forth in the itemization attached hereto with respect to the bid submitted by First Priority Emergency Vehicles, Inc.; and

**WHEREAS**, First Priority Emergency Vehicles, Inc. submitted the lowest bid and PL Custom Body & Equipment Co., Inc. submitted the next lowest bid; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding a bid to PL Custom Body & Equipment, Inc. in the amount of One Hundred Eighty Two Thousand One Hundred Seventy One Dollars (\$182,171.00);

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the bid of PL Custom Body & Equipment Co., Inc. is hereby accepted in the amount of One Hundred Eighty Two Thousand One Hundred Seventy One Dollars (\$182,171.00) less trade-in discount of Ten Thousand Dollars (\$10,000) for a net price of One Hundred Seventy Two One Hundred Seventy One Dollars (\$172,171.00); and

**BE IT FURTHER RESOLVED** that the bid of First Priority Emergency Vehicles, Inc. be and the same is hereby rejected as nonconforming and in material deviation from specifications for the reasons specifically set forth on the attached itemization of nonconformities which is incorporated herein as if fully set forth; and

**BE IT FURTHER RESOLVED** that this award is contingent upon a certification of available funds being provided; and

**BE IT FURTHER RESOLVED** that bid bonds of unsuccessful bidders may be returned; and

**BE IT FURTHER RESOLVED** that a contract with respect to proposal awarding the bid of PL Custom Body & Equipment Co., Inc. shall be prepared in form satisfactory to the Township Solicitor of the Township of Upper Deerfield and the Mayor and Clerk are hereby authorized to enter into the same.
