**AUTHORIZING AWARDING CONTRACT FOR TOWNSHIP EMPLOYEE AND VOLUNTEERS PHYSICALS TO RSP MEDICAL LLC**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing physicals to Township employees and volunteers for a term of one year beginning January 1, 2013 to December 31, 2013 from RSP Medical LLC, SJ Healthcare Occupational Health Department, Internal Medicine Assoc, and Family Practice Associates; and
