**RESOLUTION 12-292**

**RESOLUTION AWARDING BID FOR HOME REHABILITATION  
CONTRACT 2012-15**

**WHEREAS**, the Township of Upper Deerfield authorized the receipt of quotes for installation of a septic system of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Revolving Loan Account; and

**WHEREAS**, the Township of Upper Deerfield requested proposals for the installation of a septic system for Christina & Danny Godfrey, 1494 Highway 77 from Elliot’s Septic Service, Inc., Septic Solutions, Pierce Septic Systems, English Septic Systems, Tony Brago Excavating and Able Septic; and

**WHEREAS**, four proposals were received from Elliot’s Septic Service, Inc. - \$11,950, Septic Solutions - \$16,240, Pierce Septic Systems - \$24,088, and English Septic Systems- \$25,295 to install a septic system in compliance with specifications; and

**WHEREAS**, Elliot’s Septic Systems was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

**WHEREAS**, funds are available and have been certified by the local finance officer; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the rehabilitation proposal for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Elliot’s Septic Service, Inc. in the amount of \$11,950.00 for Contract 2012-15: Christina & Danny Godfrey, 1494 Highway 77, Bridgeton NJ, 08302 to be funded by Small Cities Revolving Loan Account; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Elliot’s Septic Service, Inc. for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
