

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 12-300

AUTHORIZING THE TREASURER TO REFUND OVERPAYMENT OF ANNUAL CS REGIONAL MUNICIPAL COURT ASSESSMENT TO MEMBER MUNICIPALITIES

WHEREAS, the CS Regional Municipal Court is made up of eight municipalities consisting of the Townships of Deerfield, Greenwich, Hopewell, Lawrence, Pittsgrove, Stow Creek and Upper Deerfield and the Borough of Shiloh ; and

WHEREAS, each of these eight municipalities paid quarterly installments equal to their portion of the CS Regional Municipal Court projected expenditures which was based on each municipalities three year average municipal court case load; and

WHEREAS, Upper Deerfield Township serves as the host municipality for the shared service regional court and the remaining seven municipalities paid Upper Deerfield Township the following amounts in 2012 for their share of the court expenses; Deerfield -\$51,192.46, Greenwich - \$2,426.60, Hopewell - \$15,546.96, Lawrence - \$24,266.33, Pittsgrove - \$60,597.46, Stow Creek -\$5,897.98 and the Borough of Shiloh - \$655.38.

WHEREAS, the actual expenses for CS Regional Municipal Court in 2012 were \$25,748.53 less than budgeted, resulting in overpayments of their annual assessments made by the municipalities in the following proportionate amounts; Deerfield - \$4,520.01, Greenwich - \$214.26, Hopewell - \$1,372.71, Lawrence - \$2,142.58, Pittsgrove - \$5,350.41, Stow Creek - \$521.41 and the Borough of Shiloh -\$57.93.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of Upper Deerfield Township, County of Cumberland and State of New Jersey that the municipalities of the CS Regional Municipal Court be refunded their proportionate overpayments which were made to Upper Deerfield Township to cover the budget of the CS Regional Municipal Court; and

BE IT FURTHER RESOLVED that the following proportionate amounts be refunded because of the aforesaid reasons to these municipalities Deerfield - \$4,520.01, Greenwich - \$214.26, Hopewell - \$1,372.71, Lawrence - \$2,142.58, Pittsgrove - \$5,350.41, Stow Creek - \$521.41 and the Borough of Shiloh -\$57.93; and

BE IT FURTHER RESOLVED that the Borough of Shiloh be reimbursed an additional \$178.74 due to a duplicate quarterly payment being received by the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that the Township Committee of Upper Deerfield Township authorizes the issuance of checks to these municipalities in the aforementioned amounts and that a copy of this Resolution be filed with the Chief Financial Officer and Township Administrator.
