AUTHORIZING AWARDING OF CONTRACT FOR SPRING ACTIVATION AND FALL WINTERIZATION TO CERTAIN UNDERGROUND IRRIGATION SYSTEMS WITHIN THE TOWNSHIP OF UPPER DEERFIELD
