RESOLUTION 13-191

**AUTHORIZING AWARD OF CONTRACT FOR RENOVATIONS AND ADDITIONS
TO THE EXISTING UPPER DEERFIELD EMS BUILDING**

WHEREAS, the Township of Upper Deerfield has advertised for bids for renovations and additions to the existing Upper Deerfield EMS Building; and

WHEREAS, bids were received by the Township of Upper Deerfield on July 25, 2013 from Trimark - \$714,910, Straga Bros - \$748,600, DDL Enterprises, Inc. - \$666,480, J H Williams - \$718,500, W J Gross, Inc. - \$719,000 and Ray Angelini - \$738,000; and

WHEREAS, the low bid was received from DDL Enterprises, Inc. in the amount of \$666,480.00; and

WHEREAS, the bids have been reviewed by Scott Burnley of KBA-Architecture, Inc., the architect retained by the Township of Upper Deerfield for this project and a recommendation received that the bid in the amount of \$666,480.00 is the lowest responsible bid and DDL Enterprises, Inc. is the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to DDL Enterprises, Inc. in the amount of \$666,480.00 for renovations and additions to the existing Upper Deerfield EMS Building pursuant to the bidding documents;

WHEREAS, the award of the aforesaid bid to DDL Enterprises, Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of DDL Enterprises, Inc. in the amount of \$666,480.00 for renovations and additions to the existing Upper Deerfield EMS Building, in accordance with plans and specifications is hereby awarded; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with DDL Enterprises, Inc. for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
