RESOLUTION 14-147

AUTHORIZING AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS WITHIN THE TOWNSHIP

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing the pumping out of lift stations within the Township for a term of one year beginning July 1, 2014 to June 30, 2015 from Able, C & H Disposal Service, Elliotts Septic Service Inc., and English Sewage Disposal; and

WHEREAS, proposals were received from C & H Disposal and English Sewage Disposal as follows:

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for providing lift stations pump out services to English Sewage Disposal as aforesaid.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for providing lift stations pump out services by English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2014 to June 30, 2015 as noted above for the Township of Upper Deerfield; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposals for providing lift stations pump outs by English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award English Sewage Disposal for a term of one year beginning July 1, 2014 to June 30, 2015 as noted above for the Township of Upper Deerfield; and
