WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing snow removal services within the Township for a term of one year beginning November 6, 2014 to December 31, 2015 from, C & H Disposal Services Inc., Don Rogers, English Sewage Disposal, Ricky Slade Construction, TBI Unlimited, and S & R Contractors.; and
