

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 14-341

AUTHORIZING CONTRACT AGREEMENT WITH RJM CONSTRUCTION SERVICES INC. FOR THE HAULING OF CONTAINERS FROM THE CONVENIENCE CENTER

WHEREAS, the Township of Upper Deerfield is desirous of providing services for the hauling of containers from the Convenience Center; and

WHEREAS, the Township requested and received bids with respect to the charges for such services from RJM Construction Services Inc., C & H Disposal Services Inc., Giordano Recycling, Russell Reid Waste and Disposal Service Company Inc. and Waste Management; and

WHEREAS, the amount of such services is greater than the bid threshold on an annual basis; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding a three year contract for the hauling of containers to the Cumberland County Landfill, Giordano’s and Cumberland Recycling from the Upper Deerfield Township Convenience Center to RJM Construction Services Inc of Gloucester City, New Jersey who was the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a three year contract agreement beginning January 1, 2015 through December 31, 2017, with a municipal sixty day cancellation notice for the provision of the hauling of containers from the Convenience Center on a per load basis to various disposal locations as specified in RJM Construction Services Inc. bid document, which is hereby accepted; and

BE IT FURTHER RESOLVED, that the hauling prices to the Cumberland County Landfill, Giordano’s and Cumberland Recycling for the three year contract are as follows: \$99.50 per container for 2015, \$109.45 per container for 2016 and \$114.50 per container for 2017, hauling to Deerfield Organics at \$40.00 per container for each of the three years, loading and hauling brush to Deerfield Organics at \$60.00 per container for each of the three years and loading and hauling brush to SJAP \$70.00 per container for each of the three years; and

BE IT FURTHER RESOLVED that the proper account numbers will be charged and funds encumbered prior to services being provided and said contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2015, 2016 and 2017 budgets.
