

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 14-86**

**AUTHORIZING AWARD OF CONTRACT FOR MODULAR ADA ACCESSIBLE BATHROOMS AT THE UPPER DEERFIELD BASEBALL AND FOOTBALL AREAS**

**WHEREAS**, the Township of Upper Deerfield has advertised for bids for the purchase and installation of modular ADA accessible bathrooms at the Upper Deerfield baseball and football areas; and

**WHEREAS**, bids were received by the Township of Upper Deerfield on April 1, 2014 from Mobilease Modular Space - \$181,468 base bid and \$14,336 for alternate #1 and DDL Enterprises, Inc. - \$173,410 and \$15,900 for alternate #1; and

**WHEREAS**, the low base bid was received from DDL Enterprises, Inc. in the amount of \$173,410.00; and

**WHEREAS**, the bids have been reviewed by the Township Engineer, and a recommendation received that the base bid in the amount of \$173,410.00 is the lowest responsible bid and DDL Enterprises, Inc. is the lowest responsible bidder; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to DDL Enterprises, Inc. in the amount of \$173,410.00 for the purchase and installation of modular ADA accessible bathrooms at the Upper Deerfield baseball and football areas pursuant to the bidding documents;

**WHEREAS**, the award of the aforesaid bid to DDL Enterprises, Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the base bid of DDL Enterprises, Inc. in the amount of \$173,410.00 for the purchase and installation of modular ADA accessible bathrooms at the Upper Deerfield baseball and football areas, in accordance with plans and specifications is hereby awarded; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with DDL Enterprises, Inc. for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
