RESOLUTION # 15-305

**AMENDING AWARD BID TO RICKY SLADE CONSTRUCTION INC. FOR
THE RESURFACING OF BUTTON MILL ROAD**

WHEREAS, the Township of Upper Deerfield authorized bids with respect to the resurfacing of Button Mill Road within the Township of Upper Deerfield; and

WHEREAS, bids were received on October 14, 2015 from Asphalt Paving Corporation - \$333,772.00 for the base bid, \$70,711.00 for Alternate #1 and \$63,237.00 for Alternate #2, from Ricky Slade Construction, Inc. - \$262,821.45 for the base bid, \$51,154.00 for Alternate #1 and \$48,435.00 for Alternate #2, and from South State, Inc. - \$289,765.75 for the base bid, \$51,154.00 for Alternate #1 and \$44,340.00 for Alternate #2; and

WHEREAS, The Township Committee of the Township of Upper Deerfield adopted Resolution 15-298 on October 15, 2015 awarding the base bid contract to Ricky Slade Construction, Inc. of Bridgeton, New Jersey to repave Button Mill Road in the amount of \$262,821.45; and,

WHEREAS, funds are now available to award Alternate #1 to repave the east bound lane of Cornwell Drive from Old Deerfield Pike to Button Mill Road in the amount of \$51,154.00 and Alternate #2 to repave Button Mill Road from Dawson Drive to Cornwell Drive in the amount of \$48,435.00 as set forth in the bid specifications to the lowest responsible bidder, Ricky Slade Construction, Inc.; and

WHEREAS, the Engineer has recommended that the base bid be awarded to Ricky Slade Construction, Inc. in the amount of \$262,821.45 as the lowest responsible bidder and that Alternate #1 in the amount of \$51,154.00 and Alternate #2 in the amount of \$48,435.00 be awarded to Ricky Slade Construction, Inc. as the lowest responsible bidder at such time that the funds are available; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of amending the base bid contract awarded on October 15, 2015 bid to Ricky Slade Construction, Inc., to include Alternate #1 in the amount of \$51,154.00 and Alternate #2 in the amount of \$48,435.00 bringing the total contract amount to \$362, 410.45; and

WHEREAS, the award of the aforesaid bid to Ricky Slade Construction, Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the amended contract amount and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of Ricky Slade Construction, Inc. be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into the amended contract which includes the base bid for the resurfacing of Button Mill Road from Love Lane to Dawson Drive in

the amount of \$262,821.45, and for Alternate #1 to repave the east bound lane of Cornwell Drive from Old Deerfield Pike to Button Mill Road in the amount of \$51,154.00 and for Alternate #2 to repave Button Mill Road from Dawson Drive to Cornwell Drive in the amount of \$48,435.00 as set forth in the bid specifications to the lowest responsible bidder, Ricky Slade Construction, bringing the total contract amount to \$362, 410.45 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
