**AUTHORIZING AWARDING CONTRACT FOR PROVIDING JETTING

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing jetting and or vaccing sewer pipes and or storm drainage pipes within the Township for a term of one year beginning July 1, 2016 to June 30, 2017 from English Sewage Disposal, GE Mechanical Inc, Video Pipe Services; and

WHEREAS, proposals were received from English Sewage Disposal, GE Mechanical, Inc. Municipal Maintenance Co. and Video Pipe Services, Inc. as follows:

WHEREAS, the Treasurer has reviewed the proposals and determined that the lowest responsible proposals were submitted by English Sewage Disposal; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the services for providing jetting and or vaccing sewer pipes and or storm drainage pipes to English Sewage Disposal, as aforesaid.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for jetting / vaccing sewer pipes and or storm drainage pipes by English Sewage Disposal are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award routine and emergency service for a term of one year beginning July 1, 2016 to June 30, 2017 as noted above for the Township of Upper Deerfield; and
