RESOLUTION 16-168

**AUTHORIZING AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS
WITHIN THE TOWNSHIP**

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing the pumping out of lift stations within the Township for a term of one year beginning July 1, 2016 to June 30, 2017 from C & H Disposal Service and English Sewage Disposal; and

WHEREAS, proposals were received from C & H Disposal and English Sewage Disposal as follows:

WHEREAS, the Treasurer has reviewed the proposals and determined that the lowest responsible proposals was submitted by English Sewage Disposal, and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for providing lift stations pump out services to English Sewage Disposal.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for providing lift stations pump out services by English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2016 to June 30, 2017 as noted above for the Township of Upper Deerfield; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposals for providing lift stations pump outs by English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award English Sewage Disposal for a term of one year beginning July 1, 2016 to June 30, 2017 as noted above for the Township of Upper Deerfield; and
