

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 16-271

**AWARDING BID TO PL CUSTOM EMERGENCY VEHICLES FOR
THE PURCHASE OF AN AMBULANCE**

WHEREAS, the Township of Upper Deerfield authorized bids for the purchase of an ambulance; and

WHEREAS, bids were received on September 27, 2016 from PL Custom Emergency Vehicles - \$214,643.00 for the base bid, a credit of \$15,000.00 for Alternate #1 for the trade in of 2001 ambulance and a discount of \$1,996.00 for deleting the need for a performance bond bringing the total purchase price to \$197,647.00 and from Ambulance Network - \$211,858.00 for the base bid, a credit of \$6,000.00 for Alternate #1 for the trade in of 2001 ambulance bringing the total purchase price to \$205,858.00; and

WHEREAS, PL Custom Emergency Vehicles of Manasquan, New Jersey, submitted the lowest total bid in the amount of \$214,643.00 for the base bid, a credit of \$15,000.00 for Alternate #1 for the trade in of 2001 ambulance and a discount of \$1,996.00 for deleting the need for a performance bond bringing the total purchase price to \$197,647.00 as set forth in the bid specifications; and

WHEREAS, the Engineer has recommended that the aforementioned ambulance purchase be awarded to PL Custom Emergency Vehicles in the amount of \$197,647.00 as the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the aforementioned ambulance purchase to PL Custom Emergency Vehicles as aforesaid; and

WHEREAS, the award of the aforesaid bid to PL Custom Emergency Vehicles is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the purchase of the ambulance and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of PL Custom Emergency Vehicles be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the base bid, credit for Alternate #1 and credit for deleting the need for a performance bond for the purchase of an ambulance in the amount of \$197,647.00 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that bid bonds may be returned to unsuccessful bidders; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
